Proposed Changes to Constitution & By-Laws:

The current Constitution and By-Laws of SFA state that a quorum of 10% of the membership is required to conduct business at a General Meeting. Our club is growing quickly and with close to 500 adult members now, this means that 50 club members need to be present at a General Meeting (held after the monthly work party) to conduct business and hold votes. As the average work party attendance is around 25-30 members, this is hampering the board's ability to run the club and maintain the range. Therefore, the Board would like to amend the SFA Constitution to state:

"votes held at General Meetings only require a majority vote of members present at the meeting"

In addition, the By-Laws state that any one purchase over \$1500 requires approval by the General Membership. With yearly price

Therefore, the Board would like to amend section 4A in the By-Laws to state:

"Any disbursement of Club monies over \$5000 on any one purchase must be approved by the Governing Board and the General Membership"

We will vote on the proposed changes at the Annual Club Banquet on Nov. 19.

Let's Get out the Vote

Things to think about when voting in officers this year.

1. We must look at what's good for the club overall.
2. A person who has solid judgment on matters, keeps the club out of trouble, navigate difficult situations and help the board come to the right consensus.
3. A person with motivation and strong interest in the club's well being.
4. A person who has the courage to say no to the few , for the betterment of the club over all.
5. A person that is in good standing as a member. Enforcing the membership requirements stated in the Constitution and Bylaws (a minimum of half of the required work parties each year).

A member in good standing has:

- * paid their year dues
- * participate in a minimum of six (6) work parties per year
- * follow Club rules and procedures

Members in good standing are:

- * eligible to vote on all subjects brought before the general membership
- * entitled to run for a position on the Board
- * eligible to vote at annual election for new Board
- * eligible to have a Club House key
